#### Dear Sir,

As per the approval of the note file (01.09.2021) by your high office, we are herewith submitting the formats for the students to apply for Grace marks, Credit Exemption and both. We request your high office to approve the same. The formats are enclosed with this note file as annexures (TKR-Form-I, TKR-Form-II, TKR-Form-III).

The above grace marks, credit exemption rules will be implemented to the students who opt for the mentioned categories only. However, the aggregate CGPA will be calculated for 186 credits only for regular admitted B.Tech students and 138 credits for lateral entry admitted B.Tech students.

After implementing the above guidelines, while printing the Consolidated Grade Memo (CGM) for B.Tech Students the following rules submitted for your approval:

## 1. For the students who pass regularly and gets eligibility for the award of degree:

a. The two subjects with least grade point will be marked with '\*' indicating that "courses registered but not counted for calculation of aggregate".

## 2. For Students who gets eligibility for the award of degree with grace marks:

- a. As per rule, 10 marks will be added for regular admitted B.Tech Students and 7 marks will be added for lateral entry admitted B.Tech students (subjected to a maximum of two subjects only).
- b. Student has to submit the original grade memo along with TKR Form-I duly filled and signed.
- c. If the student has already paid the examination fee or results wait for the particular subject, it will be void.
- d. Student has to submit an undertaking on Rs.20/- stamp paper in the format enclosed.

### 3. For Students who gets eligibility for the award of degree with exemption:

- a. As per rule, the student has to register for all 192/144 credits including mandatory subjects.
- b. The student has to secure 186 credits for regular admitted and 138 credits for lateral entry admitted.
- c. The student has to pass all the mandatory subjects without fail as per TKR-R17 regulations.
- d. Student has to submit the original grade memo along with TKR Form-II duly filled and signed.
- e. Student has to submit an undertaking on Rs.20/- stamp paper in the format enclosed.
- f. If the student has already paid the examination fee or results wait for the particular subject, it will be void.
- g. The two subjects with least grade point/applied for exemption will be marked with '\*' indicating that "courses registered but not counted for calculation of aggregate".

## 4. For students who gets eligibility for the award of degree with grace marks and exemption:

- a. As per rule, the student has to register for all 192/144 credits including mandatory subjects.
- b. As per rule, 10 marks will be added for regular admitted B.Tech Students and 7 marks will be added for lateral entry admitted B.Tech students (subjected to a maximum of two subjects only).
- c. Student has to submit the original grade memo along with TKR Form-III duly filled and signed.
- d. Student has to submit an undertaking on Rs.20/- stamp paper in the format enclosed.
