

MEMORANDUM OF UNDERSTANDING

This memorandum of understanding is made on 5th August 2024 Between **T K R Group of Institutions, Hyderabad** which is represented by its Placements Head (referred to as the First Party), and **V-Symphysis Overseas Education and Careers Pvt Limited**, Gachibowli, Hyderabad represented by its Managing Director (referred to as the Second Party).

The parties here by agree as follows:

1. This agreement between the parties shall remain in force for a duration of one year, starting from August 5th, 2024, and concluding on Aug 4th, 2025.
2. This agreement is non-exclusive, allowing both parties the freedom to engage in similar agreements with other institutions of a similar nature.
3. Neither party shall utilize the trademarks, trade names, trade dress, patents, copyrights, logos, designs, monograms, or any other intellectual property rights belonging to and used by the other party without obtaining prior written consent.
4. The First Party agrees to permit the Second Party to conduct 3-4 educational seminars for their students at the college premises. The topics for these seminars will be mutually decided upon by both parties at a later date.

6. 8. The second party shall not offer any guarantee of admission or guarantee of a visa to any student. Should any student claim such guarantees, the First Party shall not be held liable, and any disputes arising from such claims shall be the sole responsibility of the Second Party to resolve.

9. The second party shall not charge any fees from the student exorbitantly and the fee will be paid by the student to the second party directly. In case of any dispute concerning these fees, the First Party bears no liability, and it is the sole responsibility of the Second Party to address and resolve the matter with the student.
10. The Second party will be allowed to conduct campus activities related to study abroad during this one year with the consent of the First Party.
11. Each party shall uphold the goodwill, reputation and data confidentiality of the other and operate in full compliance with all relevant laws. Neither party shall engage in any illegal activities, including the use of counterfeit documents.
12. There are no oral or implied agreements and no oral or implied warranties or understanding between the Parties.

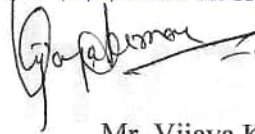
