The Minutes of the 25<sup>th</sup> BoG meeting held on 20/12/2017 has been approved by the Academic Council.

Item No.	Description of Item
03/26 BoG_DEC-19	The new Regulations under R 19 scheme are to be formulated as per the Model Curriculum of AICTE for M.Tech Program.

The members of BoG made suggestions for implementing the model curriculum for available UG and PG courses, in consultation with BOS for the effective dissemination of practical courses as suggested in the model curriculum.

04/26 BoG_DEC-19	The Single Evaluation system is to be implemented by the direction of the 26 <sup>th</sup> BoG Meeting held on 23/11/2019.

From the result analysis, it was identified that the Double Evaluation system is not supportive to meet the set target of overall student academic attainment levels. Hence the Members of BoG have directed the academic Council to take the following guideline for implementing the single evaluation system.

The Existing procedures of Non-Autonomous Institutions regulated by JNTUH (Affiliating University) are to be implemented concerning for Re-counting, Re-evaluation and challenging Valuation of Marks.

**The BOG has approved the Single Evaluation System for the students admitted under 19-20 Academic Year.**

05/26 BoG_DEC-19	Improvement in position through NIRF

The members advised the improvement in the position in NIRF, can be achieved, by public perception using Alumni (Alumni Meets), one student technical fest by each department per year, one National Conference per Year, as these parameters support for the student community and faculty community interactions based on current technological trends. Also, the National Ranking framework theme is based on these parameters.

06/26 BoG_DEC-19	Proposal for New courses as per the demand of software industries for recruitment in the emerging areas of Artificial Intelligence, Information Security under UG Program.

After elaborate discussions for the said item no.6, the members of BoG have suggested going with new courses as per the eligibility without compromising in infrastructural facilities and quality of education. It is also, suggested to consider the nomenclature of new courses as per AICTE norms.

**The BoG has approved for the proposal of two new courses as per AICTE norms and nomenclature and directed the Academic council for necessary measures.**

The BoG has approved the course structure formulated in consensus of BOS for 68 credits in total as per the model curriculum with minor amendments across the semester wise credit allocation and recommended the same for implementation by Academic Council

08/26 BoG_DEC-19	Mandatory Courses: Amendment in 2 <sup>nd</sup> para of 3.2.2. Credit courses of R 18 Academic Regulations

As per 3.2.2 Credit Courses of the R 18 Regulations, the Mandatory Courses like Environmental Science, Professional Ethics, Gender Sensitization lab and other social context courses and student activities like NCC/NSO and NSS are identified as Mandatory Courses. These courses do not carry credits.

Rather than be specific and limiting the mandatory courses, it is made flexible for the individual department to offer two mandatory courses of their choice, during the entire four-year program.

The said item is approved subjected to the requirement as directed by the Academic Council.

09/26 BoG_DEC-19	The Regulations under R 18 for UG programs and MBA with detailed Curriculum formulated by the consensus of BoS, Academic Council are to be ratified.

The Members of BoG have approved the detailed curriculum for UG programs, MBA Program under R18 Regulations, as per the approval of BoS, Academic Council.
