3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The programmes have been granted provisional accreditation for 2 years. As such TKR College of Engineering & Technology, Medbowli, Meerpet, Saroornagar, Hyderabad-500 097, A.P., should submit the Self Assessment Report alongwith a Compliance Report atleast after one year to be considered by the Engineering Evaluation and Accreditation Committee (EEAC) to formulate a view whether compliance report is enough to recommend for accreditation or a visit to the Institute is necessary. The recommendations of the EEAC will be considered by the Sub-Committee of the Academic Advisory Committee of Engineering for a decision.

5. The accreditation status awarded to the programmes as indicated in the above table does not imply that the accreditation has been granted to TKR College of Engineering & Technology, Medbowli, Meerpet, Saroornagar, Hyderabad-500 097, A.P. as a whole. As such the Institute should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is programme accreditation and not Institution accreditation. Copies of the Comprehensive Report submitted by the Chairman of the Expert Team along with the detailed reports submitted by the Expert Team which visited your institution for the programmes evaluated are enclosed for reference and to take necessary action to overcome the shortcomings, if any, pointed out by the Expert Team.
9. If the Institute is not satisfied with the decision of NBA, it may appeal within thirty days of receipt of this communication giving reasons for the same and by paying the requisite fee.

- (c) The college will apply to University Grants Commission for extension of autonomous status six months prior to expiry of the autonomy cycle. If the college does not apply within the stipulated time, University Grants Commission will be at liberty to withdraw the autonomous status of such college.


