Sir/Madam,

This is with reference to the proposal submitted by TKR College of Engineering & Technology, Survey No. 8/4, Balapur Mandal, Medbowli, Meerpet, Hyderabad-500 097 affiliated to Jawaharlal Nehru Technological University, Hyderabad under the UGC Scheme for Autonomous Colleges.

On the basis of the report of the UGC Expert Committee and on the basis of the recommendations of the Standing Committee, the Commission at its meeting held on 07.06.2017 has decided to grant autonomous status to TKR College of Engineering & Technology, Survey No. 8/4, Balapur Mandal, Medbowli, Meerpet, Hyderabad-500 097 for a period of six years w.e.f. 2017-2018 to 2022-2023.

Jawaharlal Nehru Technological University, Kukatpally, Hyderabad, Telangana-500 085 may issue necessary notification/order regarding the grant of autonomous status to the college as per the UGC Guidelines for Autonomous Colleges. The college, if eligible, shall apply for autonomy grant as per the norms laid down in the Guidelines.

The autonomous college shall be guided by the provisions of the UGC Guidelines for Autonomous Colleges. The Guidelines are available on the UGC website, www.ugc.ac.in. However, the college may take special note of the following:

- The college will constitute the Internal Quality Assurance Cell (IQAC) under intimation to UGC. The Cell will have an external Peer Team comprising of academicians of repute and will send report to UGC regarding the performance of the college. The report will also be put on public domain on the website of the College. The external peer review shall be conducted atleast once in a year.
- If the college is currently accredited by NBA only, it must undergo NAAC accreditation within two years of conferment of the autonomous status.

- (c) The college will apply to University Grants Commission for extension of autonomous status six months prior to expiry of the autonomy cycle. If the college does not apply within the stipulated time, University Grants Commission will be at liberty to withdraw the autonomous status of such college.



The State Government/ UT/ Directorate of Technical Education/ Directorate of Medical Education shall ensure that 10% of reservation for Economically Weaker Section (EWS) as per the reservation policy for admission, operational from the Academic year 2019-20 is implemented without affecting the reservation percentages of SC/ ST/ OBC(NCL) / General. However, this would not be applicable in the case of Minority Institutions referred to the Clause (1) of Article 30 of Constitution of India. Such Institution shall be permitted to increase in annual permitted strength over a maximum period of two years.
2. The Institution offering courses earlier in the Regular Shift, First Shift, Second Shift/Part Time are now amalgamated as total intake and shall have to fulfil all facilities such as Infrastructure, Faculty and other requirements as per the norms specified in the Approval Process Handbook 2023-24 for the Total Approved Intake. 3. Strict compliance of Anti-Ragging Regulation, Establishment of Committee for SC/ ST, Establishment of Internal Committee (IC), Establishment of Online Grievance Redressal Mechanism, Barrier Free Built Environment for disabled and elderly persons, Fire and Safety Certificate should be maintained as per the provisions made in Approval Process Handbook and AICTE Regulation notified from time to time.
4. In case of any differences in content in this Computer generated Extension of Approval Letter, the content/information as approved by the Executive Council / General Council as available on the record of AICTE shall be final and binding.
5. As per the AICTE Notification dated 29.01.2014 and amended thereto, it shall be mandatory for each Technical Education Institution, University Department and Institution Deemed to be University imparting Technical Education to get accreditation (NBA) for at least 60% of the eligible courses in the next ONE (1) Years' time, otherwise EoA for the subsequent Academic Year (A.Y. 2024-25) shall not be issued by the Council.
6. Deemed to be University: Institutions Deemed to be Universities (Running Technical Education Programmes), it is mandatory to have AICTE approval from the Academic Year 2018-19 in compliance of the Hon'ble Supreme Court Order dated 03-11-2017 passed in CA No.17869- 17870 /2017.

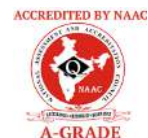
