## R-21 ACADEMIC REGULATIONS (CBCS) FOR M.Tech. (REGULAR) DEGREE PROGRAMMES

Applicable for the students of M.Tech. (Regular) programme from the Academic Year 2021-22 and onwards

### 1.0 ELIGIBILITY FOR ADMISSIONS

Admission to the above programme shall be made subject to eligibility, qualification and specialization as prescribed by the University from time to time.

Admissions shall be made on the basis of merit/rank obtained by the candidates at the qualifying Entrance Test state level conducted for PG programme as PG CET, subject to reservations as laid down by the Govt. from time to time.

### 2.0 AWARD OF M.Tech. DEGREE

2.1 A student shall be declared eligible for the award of the M.Tech. Degree, if he pursues a course of study in not less than two and not more than four academic years. However, he is permitted to write the examinations for two more years after four academic years of course work, failing which he shall forfeit his seat in M.Tech. programme.

2.2 The student shall register for all 68 credits and secure all the 68 credits.

2.3 The minimum instruction days in each semester are 90.

### 3.0 COURSES OF STUDY

Departments offering M.Tech. Programmes with specializations are noted below:

### 4.0 Course Registration

4.1 A 'Faculty Advisor or Counselor' shall be assigned to each class, who will advise the student on the Post Graduate Programme (PGP), its Course Structure and Curriculum, Choice/Option for Subjects/Courses, based on his competence, Progress, pre-requisites and interest.

4.2 Academic Section of the College invites 'Registration Forms' from students within 15 days from the commencement of class work through 'ON-LINE SUBMISSIONS', ensuring 'DATE and TIME Stamping'. The ON-LINE Registration Requests for any 'CURRENT SEMESTER' shall be completed BEFORE the commencement of SEEs (Semester and Examinations) of the 'PRECEDING SEMESTER'.

4.3 A Student can apply for ON-LINE Registration, ONLY AFTER obtaining the 'WRITTEN APPROVAL' from his Faculty Advisor, which should be submitted to the College Academic Section through the Head of Department (a copy of it being retained with Head of Department, Faculty Advisor and the Student).

4.4. If the Student submits ambiguous choices or multiple options or erroneous entries – during ON-LINE Registration for the Subjects(s) / Course(s) under a given/ specified Course Group/Category as listed in the Course Structure, only the first mentioned Subject/Course in that category will be taken into consideration.

4.5 Subject/Course Options exercised through ON-LINE Registration are final and CANNOT be changed, nor can they be inter-changed; further, alternate choices will also not be considered. However, if the subject/Course that has already been listed for Registration (by the Head of Department) in a Semester could not be offered due to any unforeseen or unexpected reasons, then the student shall be allowed to have alternate choice either for a new subject (Subject to offering of such a Subject), or for another existing Subject (Subject to availability of seats), which may be considered. Such alternate arrangements will be made by the Head of Department, with due notification and time framed schedule, within the FIRST WEEK from the commencement of Class-work for that Semester.

## 5.0 ATTENDANCE

The programmes are offered on unit basis with each subject being considered a unit.

5.1 Attendance in all classes (Lectures/Laboratories etc) is compulsory. The minimum required attendance in each theory/Laboratory etc. is 75% including the days of attendance in sports, games, NCC and NSS activities and Minor and Mid Examinations for appearing for the End Semester examination. A student shall not be permitted to appear for the Semester End Examinations (SEE) if his attendance is less than 75%.

5.2 Condonation of shortage of attendance in each subject up to 10% (65% and above and below 75%) in each semester shall be granted by the College Academic Committee.

5.3 Shortage of Attendance below 65% in each subject shall not be condoned.

5.4 **Students whose shortage of attendance is not condoned in any subject, are not eligible to write their end semester examination of that subject and their registration shall stand cancelled.**

5.5 A prescribed fee shall be payable towards condonation of shortage of attendance.

5.6 A Candidate shall put in a minimum required attendance at least three (3) theory subjects in I Year I semester for promoting to I Year II Semester. In order to qualify for the award of M.Tech. Degree, the candidate shall complete all the academic requirements of the subjects, as per the course structure.

5.7 A student shall not be promoted to the next semester unless he satisfies the attendance requirement of the present Semester, as applicable. They may seek readmission into that semester when offered next. If any candidate fulfills the attendance requirement in the present semester, he shall not be eligible for readmission into the same semester till the completion of course.

## 6.0 EVALUATION

The performance of the candidate in each semester shall be evaluated subject-wise, with a maximum of 100 marks for theory subjects and 100 marks for practical subjects, on the basis of Internal Evaluation and End Semester Examination.

6.1 For the theory subjects 70 marks shall be awarded for the performance in the Semester End Examination and 30 marks shall be awarded for Continuous Internal Evaluation (CIE). The Continuous Internal Evaluation shall be made based on the average of the marks secured in the two Mid Term-Examinations for 20 marks each conducted and Two Minor Examinations for 10 marks each. First Minor Examination will be conducted after completion of unit 1 First Mid Term Examination will be conducted in the middle of the Semester covering 50% of syllabus (2 ½ Units). The Second Minor Examination will be conducted after completion of 3 ½ Units (between 2 ½ to 3 ½ unit).

First Minor Examination will have assignment only, second Minor Examination is conducted for a duration of 60 minutes, with 20 questions of objective pattern. Each mid-term examination shall be conducted for a total duration of 120 minutes with Part A as compulsory question (10 marks) consisting of 5 sub-questions carrying 2 marks each, and Part B with 2 questions to be answered out of 4 questions, each question carrying 5 marks.

The details of the Question paper pattern for End Examination (Theory) are given below:

- The Semester End Examination will be conducted for 70 marks. It consists of two parts.  
i) Part- A for 20 marks, ii) Part – B for 50 marks.
- Part-A is a compulsory question consisting of 5 questions, one from each unit and carries 4marks each.
- Part-B to be answered 5 Questions carrying 10 marks each. There will be two questions from each unit and only one should be answered.

- 6.2** For practical subjects, 70 marks shall be awarded for performance in the Semester End Examinations and 30 marks shall be awarded for day-to-day performance as Internal Marks.
- 6.3** For conducting laboratory end examinations of all PG Programmes, One internal examiner and one external examiner are to be appointed by the Principal of the College and the same to be informed to the controller of Examination in two weeks before commencement of the lab end examinations. The external examiner should be select from outside the College.
- 6.4** A student shall be deemed to have satisfied the academic requirements and earned the credits allotted to mini-project and seminar, if student secures not less than **50%** marks (i.e. 50 out of 100 marks) in each of them. The student would be treated as failed, if student (i) does not submit a report on mini-project, or does not make a presentation of the same before the evaluation committee as per schedule, or (ii) does not present the seminar as required in the II Year I semester, or (iii) secures less than 50% marks in mini-project/seminar evaluations. Student may reappear once for each of the above evaluations, when they are scheduled again, if student fails in such ‘one reappearance’ evaluation also, student has to reappear for the same in the next subsequence semester, as and when it is scheduled.
- 6.5** For Audit Courses the student has to obtain Satisfactory/Unsatisfactory Grade based on Internal Evaluation only. The Internal Evaluation shall be carried out for 100 marks. To obtain Satisfactory Grade the student has to secure a minimum of 50 Marks.If the candidate obtain Unsatisfactory Grade. The candidate has to reappear for Internal Evaluation as Scheduled.
- 6.6** A student shall be deemed to have secured the minimum academic requirement in a subject if he secures a minimum of 40% of marks in the Semester End examination and a minimum aggregate of 50% of the total marks in the semester End Examination and Continuous Internal Evaluation taken together.
- 6.7** In case the student does not secure the minimum academic requirement in any subject (as specified in 6.6) he has to reappear for the Semester End Examination in that subject.
- 6.8** A student shall be given one chance to re-register for the subjects if the internal marks secured by a student is less than 50% and failed in that subject for maximum of two subjects and should register within four weeks of commencement of the class work. In such a case, the student must re-register for the subjects and secure the required minimum attendance. The student attendance in the re-registered subject(s) shall be calculated separately to decide upon his eligibility for writing the Semester End Examination in those subjects. In the event of the student taking another chance, his Continuous Internal Evaluation (internal) marks and Semester End Examination marks obtained in the previous attempt stands cancelled.

**6.9** In case the student secures less than the required attendance in any subject, he shall not be permitted to write the Semester End Examination in that subject. He shall re-register for the subject when next offered.

**7.0 Examinations and Assessment-The Grading System**

**7.1** Marks will be awarded to indicate the performance of each student in each Theory Subject, or Lab/Practical's, Seminar,Project, etc., based on the % marks obtained in CIE + SEE ( Continuous Internal Evaluation + Semester End Examination, both taken together) as specified in Item 6 above, and a corresponding Letter Grade shall be given.

**7.2** As a measure of the student's performance, a 10-point Absolute Grading System using the following Letter Grades (UGC Guidelines) and corresponding percentage of marks shall be followed:

**7.3** A student obtaining F Grade in any Subject shall be considered 'failed' and is be required to reappear as 'Supplementary Candidate' in the Semester End Examination (SEE), as and when offered. In such cases, his Internal Marks(CIE Marks) in those Subjects will remain the same as those he obtained earlier.

**7.4** A student not appeared for examination then 'Ab' Grade will be allocated in any Subject shall be considered 'failed' and will be required to reappear as 'Supplementary Candidate' in the Semester End Examination (SEE), as and when offered.

**7.5** A Letter Grade does not imply any specific Marks percentage and it will be the range of marks percentage.

**7.6** In general, a student shall not be permitted to repeat any subject/Course (s) only for the sake of 'Grade improvement' or 'SGPA/CGPA Improvement'.

**7.7** A student earns Grade Point (GP) in each Subject/Course, on the basis of the Letter Grade obtained by him in that subject/Course. The corresponding 'Credit Points'(CP) are computed by multiplying the Grade Point with Credits for that particular Subject/Course.

**Credit Points (CP)= Grade Point (GP)x Credits .... For a Course**

**7.8** The Student passes the Subject/Course only when he gets **GP ≥ 6** (B Grade or above).

**7.9** The Semester Grade Point Average (SGPA) is calculated by dividing the Sum of Credit Points (∑CP) secured from All Subjects/Courses registered in a Semester, by the Total Number of Credits registered during that Semester. **SGPA is rounded off to TWO Decimal Places.** SGPA is thus computed as

$$SGPA = \frac{\sum_{i=1}^N C_i G_i}{\sum_{i=1}^N C_i} \dots \text{For each Semester,}$$

Where 'I' is the Subject indicator index (takes into account all subjects in a Semester), 'N' is the no. of Subjects 'REGISTERED' for the Semester(as specifically required and listed under the Course Structure of the parent Department),  $C_i$  is the no. of Credits allotted to the  $i^{\text{th}}$  Subject, and  $G_i$  represents the Grade Points (GP) corresponding to the Letter Grade awarded for that  $i^{\text{th}}$  subject.

- 7.10** The Cumulative Grade Point Average (CGPA) is a measure of the overall cumulative performance of a student over all Semesters considered for registration. The CGPA is the ratio of the total Credit Points secured by a student in ALL registered Courses in ALL Semesters, and the Total Number of Credits registered in ALL the Semesters. CGPA is rounded off TWO Decimal Places. CGPA is thus computed from the I Year Second Semester onwards, at the end of each Semester, as per the formula

$$\text{CGPA} = \left\{ \sum_{j=1}^M C_j G_j \right\} / \left\{ \sum_{j=1}^M C_j \right\} \dots \text{For all S Semesters registered}$$

(i.e., up-to and inclusive of S Semesters,  $S \geq 2$ ),

Where 'M' is the TOTAL no.of Subjects (as specifically required and listed under the Course Structure of the parent Department) the Student has 'REGISTERED' from the 1<sup>st</sup> Semester onwards up to and inclusive of the Semester S ( obviously  $M > N$  ), 'j' is the Subject indicator index (takes into account all Subjects from 1 to S Semesters),  $C_j$  is the no. of Credits allotted to the  $j^{\text{th}}$  Subject, and  $G_j$  represents the Grade Points (GP) corresponding to the Letter Grade awarded for that  $j^{\text{th}}$  Subject. After registration and completion of I Year I Semester however, the SGPA of that Semester itself may be taken as the CGPA, as there are no cumulative effects.

- 7.11.** For Calculations listed in Item 7.6 – 7.10, performance in failed Subjects/Courses (securing F Grade) will also be taken into account, and the Credits of such Subjects/ Courses will also be included in the multiplications and summations.

## **8.0 EVALUATION OF PROJECT/DISSERTATION WORK**

Every student shall be required to submit a thesis or dissertation on a topic approved by the project Review Committee.

- 8.1** A Project Review Committee (PRC) shall be constituted with Head of the Department as Chairperson, Project Supervisor and one senior faculty member of the Departments offering the M.Tech. Programme.
- 8.2** Registration of Project Work: A student is permitted to register for the project work after satisfying the attendance requirement of all the subjects, both theory and practical.
- 8.3** After satisfying 8.2, a candidate has to submit, in consultation with his Project Supervisor, the title, objective and plan of action of his project work to the PRC for approval. Only after obtaining the approval of the PRC the student can initiate the project work.
- 8.4** If a student wishes to change his supervisor or topic of the project, he can do so with the approval of the PRC. However, the PRC shall examine whether or not the change of topic/supervisor leads to a major change of his initial plans of project proposal. If yes, His date of registration for the project work starts from the date of change of Supervisor or topic as the case may be.
- 8.5** Student shall submit his project status report in two stages at least with a gap of 3 months between them.
- 8.6** The work on the project shall be initiated at the beginning of the III semester and the duration of the project is two semesters. A student is permitted to submit Project Thesis only after successful completion of all theory and practical courses with the approval of PRC not earlier than 40 weeks from the date of registration of the project work. For the approval of PRC the student shall submit the draft copy of thesis to the Head of the Department and make an oral presentation before the PRC.
- 8.7** After approval from the PRC, the soft copy of the thesis should be submitted to the Examination Branch for ANTI-PLAGIARISM for the quality check and the plagiarism report should be included

in the final thesis. If the copied information is less than 30% then only thesis will be accepted for submission.

- 8.8** Three copies of the Project Thesis certified by the supervisor shall be submitted to the College.
- 8.9** For Project work Review I in III Semester. There is an internal marks of 100, the evaluation should be done by the PRC for 50 marks and Supervisor will evaluate for 50 marks. The supervisor and PRC will examine the Problem Definition, Objectives, Scope of Work, and Literature survey in the same domain. A student has to secure a minimum of 50% of marks to be declared successful for Project Work review I. If he fails to fulfill minimum marks, he has to reappear as scheduled.
- 8.10** For Project work Review II in IV semester, the evaluation shall be performed by the PRC and Supervisor. The PRC will examine the overall progress of the Project Work and decide the project is eligible for final submission or not. If the PRC is not satisfied with the performance and completion status. The candidate has to reappear before PRC as Scheduled.
- 8.11** For Project Evaluation (Viva Voce) in IV semester. There is an external marks of 100 and the same evaluated by the External examiner appointed by the Controller of Examination. The student has to secure minimum of 50% marks in Project Evaluation (Viva-Voce) examination.
- 8.12** If he fails to fulfill as specified in 8.11, he will reappear for the Viva-Voce examination only after three months. In the reappeared examination also, fails to fulfill, he will not be eligible for the award of the degree.
- 8.13** The thesis shall be adjudicated by one examiner nominated by the Principal of the College. For this, the Head of the Department through Controller of Examinations shall submit a panel of 3 examiners, eminent in that field, with the help of the concerned guide.
- 8.14** If the report of examiner is not favorable, the student shall revise and resubmit the Thesis. If the report of the examiner is unfavorable again, the thesis shall be summarily rejected.
- 8.15** If the report of the examiner is favorable, Project Viva-voce examination shall be conducted by a board consisting of the Supervisor, Head of the Department and the external examiner who adjudicated the Thesis.
- 8.16** The Head of the Department shall coordinate and make arrangements for the conduct of project viva-voce examination.

## **9.0 AWARD OF DEGREE AND CLASS**

- 9.1** A Student who registers for all the specified Subjects/Courses as listed in the Course Structure, satisfies all the Course Requirements, and passes the examinations prescribed in the entire PG Programme (PGP), and secures the required number of 68 Credits (with CGPA  $\geq 6.0$ ), shall be declared to have 'QUALIFIED' for the award of M.Tech. Degree in the chosen Branch of Engineering and Technology with specialization as he is admitted.
- 9.2** A student is awarded one among the class as given in below table based on CGPA, if he has satisfied the requirements prescribed for the completion of the programme and is eligible for the award of M.Tech. Degree.

<b>First class with Distinction</b>	$\geq 7.75$
<b>First Class</b>	$6.75 \leq \text{CGPA} < 7.75$
<b>Second Class</b>	$6.00 \leq \text{CGPA} < 6.75$

**9.3** A student with final CGPA (at the end of the PGP) < 6.00 will not be eligible for the Award of Degree.

## **10. WITHHOLDING OF RESULTS**

If the student has not paid the dues, if any, to the college or if any case of indiscipline is pending against him, the result of the student will be withheld and he will not be allowed into the next semester. His degree will be withheld in such cases.

## **11.0 TRANSITORY REGULATIONS**

**11.1** If any student is detained due to shortage of attendance in one or more subjects, they are eligible for re-registration to maximum of two earlier or equivalent subjects at a time as and when offered.

**11.2** The student who fails in any subject will be given two chances to pass the same subject otherwise, he has to identify an equivalent subject as per the R15 academic Regulations.

## **12.0 GENERAL**

**12.1** Credit: A unit by which the course work is measured. It determines the number of hours of instructions required per week. One credit is equivalent to one hour of teaching (lecture or tutorial) or two hours of practical work/field work per week.

**12.2** Credit Point: It is the product of grade point and number of credits for a course.

**12.3** Wherever the words “he”, “Him”, “his”, occur in the regulations, they include “she”, “her”.

**12.4** The academic regulation should be read as a whole for the purpose of any interpretation.

**12.5** In the case of any doubt or ambiguity in the interpretation of the above rules, the decision of the Chairman TKRES/Board of Governors is final.

**12.6** The College may change or amend the academic regulations or syllabi at any time and the changes or amendments made shall be applicable to all the students with effect from the dates notified by the college.

Expulsion from the examination hall and cancellation of the performance in that subject only of all the candidates involved. In case of an outsider, he will be handed over to the police and a case is registered against him.
2.	Has copied in the examination hall from any paper, book, programmable calculators, palm computers or any other form of material relevant to the subject of the examination (theory or practical) in which the candidate is appearing.	Expulsion from the examination hall and cancellation of the performance in that subject and all other subjects the student has already appeared including practical examinations and project work and shall not be permitted to appear for the remaining examinations of the subjects of that Semester/year.  The Hall Ticket of the student will be cancelled.
3.	Impersonates any other candidate in connection with the examination.	The student who has impersonated shall be expelled from examination hall. The candidate is also debarred and forfeits the seat. The performance of the original student who has been impersonated, shall be cancelled in all the subjects of the examination (including practicals and project work) already appeared and shall not be allowed to appear for examinations of the remaining subjects of that semester/year. The student is also debarred for two consecutive semesters from class work and all examinations. The continuation of the course by the student is subject to the academic regulations in connection with forfeiture of seat. If the imposter is an outsider, he will be handed over to the police and a case is registered against him.
4.	Smuggles in the Answer book or additional sheet or takes out or arranges to send out the question paper during the examination or answer book or additional sheet, during or after the examination	Expulsion from the examination hall and cancellation of performance in that subject and all the other subjects the student has already appeared including practical examinations and project work and shall not be permitted for the remaining examinations of the subjects of that semester/year. The student is also debarred for

		two consecutive semesters from class work, and all examinations. The continuation of the course by the student is subject to the academic regulations in connection with forfeiture of seat.
5.	Uses objectionable abusive or offensive language in the answer paper or in letters to the examiners or writes to the examiner requesting him to award pass marks.	Cancellation of the performance in that subject.
6.	Refuses to obey the orders of the Chief Superintendent/Assistant-Superintendent/any officer on duty or misbehaves or creates disturbance of any kind in and around the examination hall or organizes a walk out or instigates others to walk out, or threatens the officer-in charge or any person on duty in or outside the examination hall of any injury to his person or to any of his relations whether by words, either spoken or written or by signs or by visible representation, assaults the officer –in-charge or any person on duty in or outside the examination hall or any of his relations, or indulges in any other act of misconduct or mischief which result in damage to or destruction of property in the examination hall or any part of the college campus or engages in any other act which in the opinion of the officer on duty amounts to sue of unfair means or misconduct or has the tendency to disrupt the orderly conduct of the examination. If student of the college, who is not a candidate for the particular examination or any person not connected with the college indulges in any malpractice or improper conduct mentioned in clause 6 to 8.	Student of the colleges expulsion from the examination has and cancellation of the performance in that subject and all other subjects the candidate has already appeared including practical examinations and project work and shall not be permitted for the remaining examinations of the subjects of that semester/year. The candidate is also debarred and forfeits the seat. Person(s) who do not belong to the college will be handed over to police and a police case will be registered against them.
10.	Comes in a drunken condition to the examination hall.	Expulsion from the examination hall and cancellation of the performance in that subject and all other subjects the candidate has already appeared including practical examinations and project work and shall not be permitted for the remaining examinations of the subjects of that semester/year.
11.	Copying detected on the basis of internal evidence, such as during valuation or during special scrutiny.	Cancellation of the performance in that subject and all other subjects the candidate has appeared including practical examinations and project work of that semester/year examinations.
12.	If any malpractice is detected which is not covered in the above clauses 1 to 11 shall be reported to the college for further action to award suitable punishment.	

### **Malpractices identified by special invigilators**

1. Punishments to the students as per the above guidelines.
2. A show cause notice shall be issued to the Invigilator.
